Sir,

I am directed to inform that on consideration of the representations / objections submitted by the Officers, in pursuant to this Court's Letter No. 14044 to 14137/Apptt. Dated 16<sup>th</sup> October, 2012 regarding roster of the Officers of Superior Judicial Service appointed on promotion since the year 2008 to 2011 under relevant Rules, 2001, Hon'ble Court have been pleased to reject the prayer made by the Officers except the prayer of Sri Rama Shanker Shukla and Sri Praddep Kumar Maitra for switching the option from rule 4 (c) to Rule 4 (b).

I am also directed to inform that the Court have been pleased to order that looking into the peculiar circumstances that Limited Competitive Examination was not conducted for the benefit of the ten Officers promoted in the year 2008 (i.e. from Sri Dinesh Chandra Ray to Sri Sajjan Kumar Dubey), though the roster system is in vogue since the year 2004, these Officers are kept out of the ambit of the roster and are placed *en block* after Shri Prem Prakash Pandey in the Civil List of the Judicial Officers.

Further the Court have been pleased to fix the final seniority of the Officers of Superior Judicial Service appointed by way of promotion under Rule 4(b) & 4 (c) in the year 2011 as per roster and are placed after Sri Sajjan Kumar Dubey in the Civil List by way of allowing the prayer of Sri Rama Shanker Shukla and Sri Pradeep Kumar Maitra.

I am further directed to say that the Court have been pleased to order to circulate the final seniority list of the Officers of Superior Judicial Service prepared on the basis of above two counts Sl. No. 38 to 84 (i.e. from Mr. Mr. Dinesh Chandra Ray to Mr. Bipin Bihari) amongst the concerned Officers for information.

It is made clear that aforesaid final seniority / roster has been prepared taking into account of all the Officers promoted from the year 2008 to 2011 but some of them have already retired viz. Sri Dinesh Chandra Ray, Sri Sada Sheo Rao, Sri Madan Mohan Singh, Sri Ganpati Tiwari, Sri Raj Narayan Tiwari, Sri Ramendra Nath Rai, Sri Binoy Kant Khan, Sri Birendra Pratap Singh, Sri Kamlesh Mishra, Sri Nirmal Kumar Agarwal and Sri Shiv Pujan Tiwari and as such their names do not find place in the Civil List.

Also aforesaid roster arrangements for their seniority shall be subject to final decision of the Hon'ble Supreme Court in Special Leave to Appeal (Civil) No. 9883 of 2009.

You are, therefore, requested to circulate the Letter and enclosed Civil List / final Seniority List of the Officers at Sl. No. 38 to 84 amongst all concerned.
