ADVERTISEMENT NO. : 03/2013

Consequent upon creation of new posts, applications are invited from the eligible candidates to fill up the vacancies, on temporary basis, of **Legal Assistant** in the scale of Pay Rs. 9300-34800/- with grade pay of Rs.4600/- (plus other usual allowances as per rule).

Candidates should submit application for the said post in the prescribed format given below, addressed to the Registrar General, Jharkhand High Court, Ranchi by Registered post/Speed post only. The last date for receipt of application is 15.04.2013. However, candidates who have already applied in response to Court's Advertisement No. 02/2012 dated 20.09.2012, need not apply afresh and their candidature shall be considered for the newly created posts also on the basis of their earlier application, subject to fulfilment of eligibility criteria of this advertisement with regard to maximum Age.

ELIGIBILITY CRITERIA

1. Law Graduate from any recognized University having the experience of at least three years practice as a Lawyer.
2. The candidates should possess sound health, good moral character and should not be involved in or related to any criminal case of any type involving moral turpitude.
3. The candidates must be above 25 years of age as on the 01.03.2013 but not more than the age of 35 years in case of General Category, 38 years in case of E.B.C(B.C-I) & B.C(B.C-II). Category and 40 years in case of S.C./S.T/PH. Category.
4. Reservation policy of the State Government will apply and the benefit of the same shall be given to the candidates belonging the State of Jharkhand only. The candidates of the other States in the Reserved Category shall be treated as General Category candidate.

ENCLOSURES: Candidates are required to enclose:-

1. Original Bank Draft of Rs. 500/- (Five Hundred only) for General category, E.B.C. (Schedule I), B.C. (Schedule II) and Rs. 125/- (One Hundred twenty five only) for S.C and S.T. category, drawn on any Nationalized Bank payable at Ranchi in favour of Registrar General, Jharkhand High Court, Ranchi, towards the payment of examination fee.
2. Three recent passport size photographs (including one, duly attested by Gazetted Officer), should be affixed on the application form.
3. One self addressed unstamped envelope of 10X4½ Cm.
4. Photocopy of the Matriculation Certificate in proof of date of birth duly attested by a Gazetted Officer.

5. Photocopy of the Provisional/ Original Certificate of LL.B. from a recognized University, Photocopy of the certificate regarding enrollment in the Bar Council both duly attested by a Gazetted Officer and Experience Certificate (in original) at the Bar to be signed by the President/Secretary of the High Court/District Bar Association and countersigned by The Registrar General of the High Court/Principal District Judge of Civil Courts or any other equivalent authority.
6. Photocopy of the Domicile Certificate and Caste Certificate issued by the District Magistrate/Deputy Commissioner or by competent authority verified and countersigned by the District Magistrate/Deputy Commissioner as well as (in case of reserved category only) duly attested by a Gazetted Officer.
8. Photocopy of the Handicapped certificate issued by the competent authority in case of Handicapped candidate, duly attested by a Gazetted Officer.

IMPORTANT

1. The application is to be filled up in English only.
2. The appointment will be made strictly from the panel of successful candidates prepared on the basis of merit.
3. The merit list of the candidates for the purpose of appointment shall be prepared on the basis of a written test to be followed by Viva-Voce test. Only the candidates getting the qualifying marks in the written test shall be called for Viva-Voce test.
4. The decision of the Selection Committee/High Court for recruitment of all the post shall be final and binding on all concerned and no communication shall be entertained.
5. The information regarding schedule of the Examination and venue will be announced later on.
6. The Admit Cards indicating the date of Examination and venue shall be forwarded to the candidates individually by post. If, however, any candidate does not receive the Admit Card, he/ she may contact the Registrar General of High Court at least two days before the scheduled date of examination.
7. The name and address of the candidates must be mentioned on the overleaf of Demand Draft.
8. Incomplete application not conforming to the aforesaid prescribed requirements shall be rejected and no further communication will be entertained in this regard.
9. Canvassing in any form shall result in rejection of the candidature.
10. On the envelope containing the application form the words "Application for the post of **Legal Assistant** must be inscribed.
